

Legislators will tackle pension issues in 2013

The 2013 Legislative session begins with a new round of concerns about the post-recession health of public pension funds in Minnesota and across the country.

In fact, a Jan. 19 *StarTribune* <http://www.startribune.com/politics/statelocal/187610341.html> article stated that Minnesota's public pension plans are "...worse off than they were..." before sustainability legislation was enacted in 2010".

Not true, said in the executive directors of TRA, MSRS and PERA. In a Jan. 22 statement they called the *StarTribune's* claims incorrect and its story 'skewed'. The leaders didn't stop there. They said the "... numbers used to back up the *StarTribune's* claim were highly misleading...

"In fact", they said, " on a market -- or real -- value basis, the Teachers Retirement Association (TRA) went from 59.8 percent funded in 2009 to 72.5 percent funded in 2012.

The Minnesota State Retirement System (MSRS) General Plan improved from 65.6 percent funded in 2009 to 82 percent funded in 2012, thanks in large part to the 2010 reforms. **In total, the 2010 reforms reduced benefit liabilities for the pension funds by \$5.9 billion."**

As media and political attacks on public employee pensions continue, the **Committee of Thirteen** will be at the legislature providing accurate information and working to protect your pension.
